## 2 Project update: e-Tablets

- Selected model: TBC in the coming days
- User guides to be developed – training options being considered (on-line demo)
- Hands on training recommended as part of LLQP program

## 2 Project update: sample questions

- First samples published early October
  - One question per competency component (a little over a dozen in total)
  - Information provided: question, answer, explanations and references (Curriculum and exam prep. material)
- Additional samples to be released in the coming weeks (before year end)
  - One question per competency sub-component (about a dozen/module, or 40% of questions)



## 2 Project update: other tools online

- Exam validity control mechanisms
  - Detailed report covering material presented at earlier Stakeholder meetings
- Question drafting and review guidelines
  - Tool used for CISRO SME mandates
  - Potential tool for Course Providers to assist in development of certification exam questions
- FAQs currently being developed based on Stakeholder feedback (TBC)

# 3.1 Transition

## 3.1.1 Historical background

- Significant changes brought by original LLQP
- Reduced pass rate as safety net
- Satisfactory results rendering transitional measure unnecessary



## 3.1.2 Basis for CISRO decision

- Safety net requested by Stakeholders – options considered include
  - Reduced pass rate
  - Pilot in select jurisdictions only
  - Temporary compensatory marking

## 3.1.2 Basis for decision (cont.)

- Harmonized LLQP bringing less significant changes
  - Similar breadth of material
  - Anticipation that reduced pass rate unnecessary
- Harmonized LLQP bringing changes nonetheless
  - New exam preparation material
  - New exam questions
  - New marking approach

## 3.1.3 Selected transition model

- Modular marking in Quebec (no change to current model)
- Pilot in Alberta
- Compensatory marking option in other jurisdictions (TBC) for transition period

## 3.1.4 Length of transition

- Sufficient time to gather statistically significant data
  - 1,000 writes on 3 sets of formats per module
  - Ongoing adjustments by AMF
  - Independant psychometric report
  - 45-day notice period of end of transition following publication of expert report



## 3.2 Registration process

- Possibility of registering before certification to be confirmed with jurisdictions

## 4. Funding

- Licence fee formula: development costs and annual maintenance costs divided by number of students over 5 years

# 4.1 Licence fee formula

Development costs	Original Forecast	Actuals/reviewed projections
Salaries and office expenses	\$745,000	\$497,755
Occupational workshops	\$190,000	\$95,725
Curriculum	\$50,000	\$18,652
Study Material	\$2,060,000	\$893,727
Exams (incl. tablets)	\$720,000	\$848,300
Licence Agreement	\$10,000	\$8,369
<b>Totals</b>	<b>\$3,775,000</b>	<b>\$2,362,528</b>
